#### **EXECUTIVE SESSION**

Upon motion by Steve Glaser, seconded by Ralene Adler, and unanimously approved, the Board went into executive session to discuss personnel issues. Julian Kane, a member of the public left the room.

The final 1994-1995 Evaluation Report for the Library Director was completed and accepted by consensus. The Board also reviewed employment contracts of management employees.

### **PUBLIC SESSION**

Upon motion by Arthur Lerner, seconded by Ralene Adler, and unanimously approved, the Board returned to public session. Mr. Julian Kane, a member of the public, returned.

# **Employment Contracts**

1. Upon motion by Arthur Lerner, seconded by Dolly Relkin and after discussion, it was,

of Trustees of the Great Neck Library authorize and direct the Board President to execute a contract between the Board and the Administrative Support Staff on the Board's behalf, which includes the same grievance procedure and benefits as provided for in the collective bargaining agreement between the Great Neck Library and Great Neck Library Staff Association, dated January 1, 1995 through December 31, 1996, such authorization being subject to execution by the Administrative Support Staff.

BE IT HEREBY RESOLVED that the Great Neck Library positions known as "Supervisor of Circulation and On Line Catalogue"; "Supervisor of Reference and Information"; "Supervisor of Programming and Publicity"; and "Supervisor of Children's Services" shall hereafter be referred to as "Department Head of Circulation and On Line Catalog"; "Department Head of Reference and Information"; "Department Head of Programming and Publicity"; and "Department Head of Children's Services".

3. Upon motion by Arthur Lerner, seconded by Renée Zarin, and after discussion, it was stated:

BE IT HEREBY RESOLVED that the Great Neck Library approves the reappointment of Lisa M. Paulo, as the Department Head of Children's Services effective January 1, 1996 through December 31, 1996 at an annual salary of \$49,534 step 4 of the 1995 Department Heads' Salary Schedule. All other terms and conditions of employment are to be set forth in a written agreement to be executed by the parties.
